Annual Membership Renewal | Due on December 1, 2017

- Invoices for 2018 renewals will be emailed to you on October 1, 2017.
- Payments received after December 1 will include a \$100 late fee.
- REALTORS® who have not renewed by December 31 will be deemed "non-members"
- Designated REALTORS® will be charged \$530 for each non-member licensed with their company.
- Designated REALTORS® who haven't renewed their membership by December 31 will be deemed "inactive."
- CMR portion of REALTOR® Membership Dues increases \$3 annually

Quarterly Fees

- Invoices are billed to individual Subscribers via email 30 days prior to each due date.
  - An automatic \$100 late fee applies after the due date and service is disconnected.
  - To restore MLS Services, an additional \$100 reconnect fee will apply.
  - Service will not be disconnected on Friday, Saturday, Sunday or any MLS observed holiday, however, late & reconnect fees still apply.
  - MLS Participants (Brokers) are responsible for fees not paid by their subscribers.
- The Participant's MLS access will be disconnected if subscriber fees remain outstanding for more than 30 days past the original due date.
